GENERAL DESCRIPTION OF PROPOSED IMPROVEMENTS:

You must submit the following with this application:

1. A sufficiently detailed description of the improvements, using the space above and/or additional sheets if needed. If your description is not specific enough, the ARB will return your application without approval for additional information.
2. A site plan showing the size, shape, and location of improvements with respect to your home and adjoining properties (including specific dimensions of the improvements and distances to adjoining properties).
3. A grading and/or drainage plan, if applicable. Your project plan must state how it will prevent drainage and runoff from your lot to neighboring properties. You must indicate below notification of ALL affected homeowners.
4. If installing fencing or permanent lighting, indicate below notification of ALL affected homeowners. If installing fencing, ensure that the fencing will remain within the true surveyed property line and visibly mark its planned outline.
5. If your project will remove any flowering tree or broadleaf evergreen with a trunk larger than 3 inches in diameter, measured at a point 12 inches above the ground, or any other live tree with a trunk more than 4 inches in diameter, your description must identify those trees. (You do not need permission to remove dead or badly damaged trees or shrubs.)
6. Manufacturer brochures and color samples for improvements, if available.
7. For major additions or improvements, submit architectural plans or drawings.

NOTIFICATION OF NEIGHBORS:

Provide the signatures and street addresses of owners of at least two neighboring homes. If the project involves permanent exterior lighting, fences, or drainage, you must notify ALL affected homeowners. Neighbors who sign are acknowledging they have been notified about your project, NOT that they approve of it. After signing, they may contact the ARB directly to contest your project or request modifications to it.
